

ECONOMIC BULLETIN Q2 2023

Almost stable production and, slight decrease in turnover; moderate increase in manufacturing prices continued due to high input costs and steady international trade performance

Food and drink industry

Almost stable production and, slight decrease in turnover; moderate increase in manufacturing prices continued due to upward trend of some agricultural commodities' prices and high input costs such as packaging

- In Q2 2023, EU food and drink industry production increased by 0.1% compared to the previous quarter.
- EU food and drink industry turnover decreased by 0.1% compared to the previous quarter.
- The year-on-year comparison shows a decrease in both food and drink industry production and total manufacturing production (-1.2% and -0.3% respectively, compared to Q2 2022). There was a marked increase in food and drink industry turnover (6.7%) while total manufacturing turnover declined (-0.3%), compared to Q2 2022.
- Food manufacturing prices increased by 0.3% compared to the previous quarter and were up by 9.7% compared to Q2 2022.

Employment remained up in food and drink industry, slightly down in total manufacturing

- In Q2 2023, employment levels in the food and drink industry increased (0.2% and 1.4% respectively) compared to the previous quarter, while total manufacturing employment decreased (-0.3%).
- Year-on-year, employment levels increased in the food industry (0.7%), the drink industry (5.3%) and in total manufacturing (0.9%).

Food and drink industry and total manufacturing industry business confidence continue to decrease

• Food industry confidence declined for Q3 2023 (-0.7 points) and for the seventh consecutive quarter. Drink industry confidence showed a significant dropdown (-3.4 points) compared to the previous quarter. The confidence level in total manufacturing was down to a similar degree (-3.1 points).

• EU exports of food and drinks totalled €45.6 billion in Q2 2023 (Q2 2023/Q2 2022: +0.6%).

- The top 5 products with the largest share in export value generated €21.9 billion in Q2 2023 (meat products, dairy products, wine, processed fruits and vegetables, and cocoa, chocolate and sugar confectionery).
- EU imports of food and drinks reached €26 billion (Q2 2023/Q2 2022: -6.7%).

Agricultural commodities

Agricultural commodity prices continued their downward trend; continued prices' increase for sugar and coffee

- The FAO food price index decreased by 3.2% in Q2 2023 compared to the previous quarter and by 20.5% compared to Q2 2022.
- The year-on-year comparison showed a continued downward trend in EU and world market agricultural commodity prices except for sugar and cocoa.

Decrease in retail trade in foodstuffs

- Retail trade in foodstuffs in Q2 2023 decreased by 0.1% compared to the previous quarter whereas total retail trade was down 0.2%.
- Year-on-year, retail trade in foodstuffs decreased by 3.4% whereas total retail trade decreased by 2.1%.
- Consumer prices increased by 1.8% compared to the previous quarter and 15.2% year-on-year.





Food industry employment by Member State



The indicator is calculated as the simple arithmetic average of the seasonally adjusted balances of positive and negative answers to specific questions, e.g. regarding economic expectations.



EU food and drink trade (€ billion)








EU turnover in retail trade by economic activity, 2015-2023 (2015=100)

Food and drink producer prices, consumer prices and inflation

- In August 2023, EU food and drink producer prices increased by 5% compared to August 2022 (highest year-on-year value - 21.5% - in October 2022).
- Consumer food prices registered a 9.2% increase since September 2022 (highest - 19.6% - in March 2023).
- Inflation was up by 4.9% in September 2023 yearon-year (highest year-on-year value 11.5% value in October 2022).

Energy prices

Crude oil and natural gas

- In October 2023, crude oil prices decreased by 2% on average compared to October 2022.
- EU natural gas prices decreased by 63% since October 2022.

Global shipping and air freight

- The global container freight rate index decreased by 69% between October 2022 and October 2023.
- Air freight rates were down 32% compared to October 2022.

Packaging

Wood and paper

- August year-on-year, producer prices index of wooden containers dropped by 15%, but were up 39% compared to August 2020.
- Producer price indices of pulp, paper and paperboard dropped by 15% compared to August 2022, but were up 35% compared to August 2020.

Plastics and metal

- The producer price index of plastic packing goods has decreased by 3% compared to August 2022, but was up 24% compared to August 2020.
- The August year-on-year comparison shows that the producer price index of light metal packaging

grew by 6%, but was up 35% compared to August 2020.

 The producer price index of machinery for food and drink processing registered a 3% increase since August 2022.

- The job vacancy rate in the EU manufacturing industry marked a decrease since Q2 2022 (Q2 2023/Q2 2022: -13%).
- In Q2 2023, the job vacancy rate in the manufacturing industry varied across Member States, from 4.4% in the Netherlands to 0.8% in Poland.

Agricultural raw materials

- The FAO food price index was down 10.9% compared to October 2022.

Animal feed

- Producer prices of animal feed increased since August 2020, plateaued in the second half of 2022, and started to decrease in Q1 2023.
- The August 2023 year-on-year comparison shows that the producer price index of animal feed was down by 8%, but was up 34% compared to August 2020.

 In October 2023 year-on-year, prices of diammonium phosphate, triple superphosphate and urea decreased by 26%, 31% and 35% respectively, but remained 50%, 61% and 68% higher compared to August 2020.
